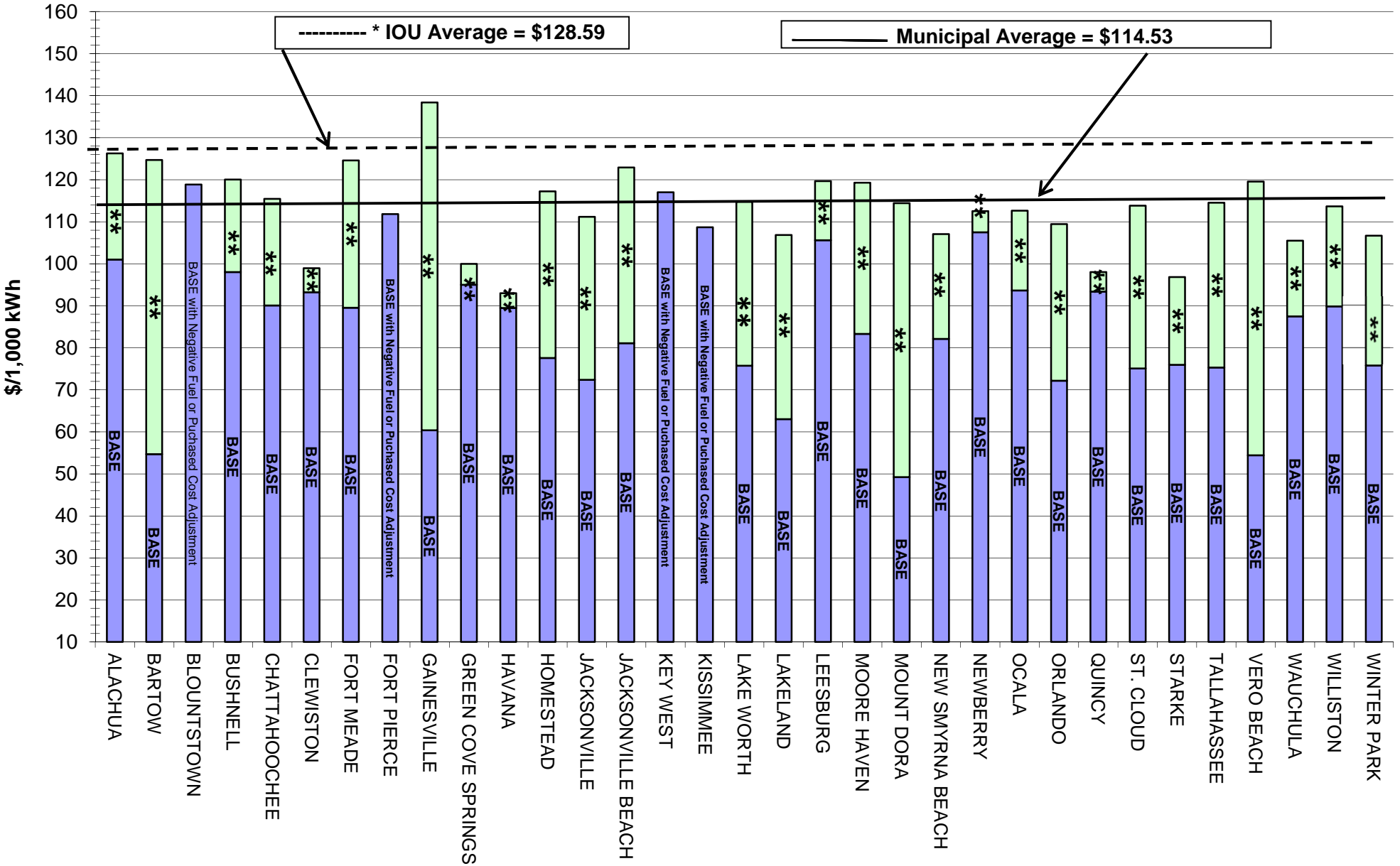


Residential Bill Comparison, December 2015

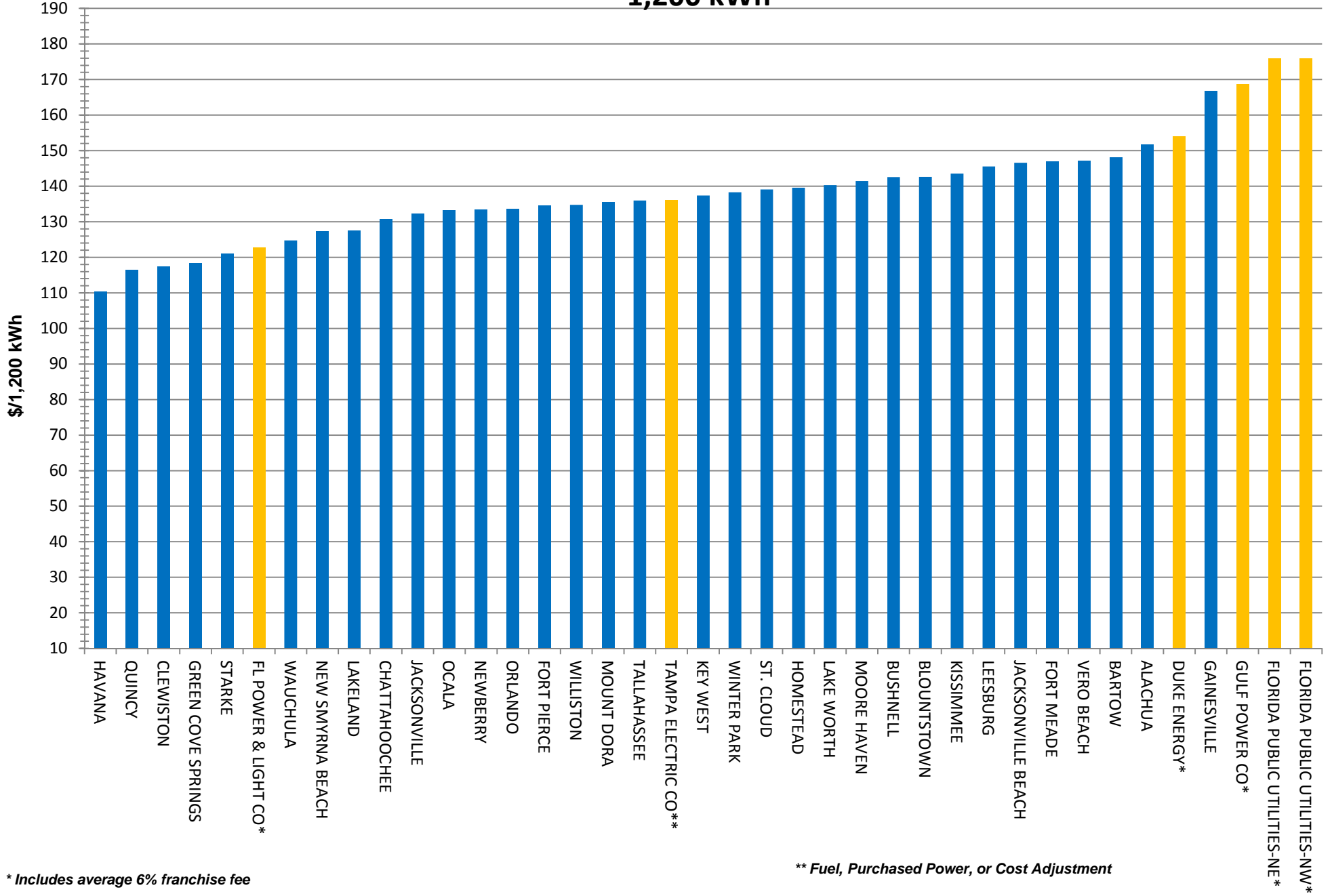
