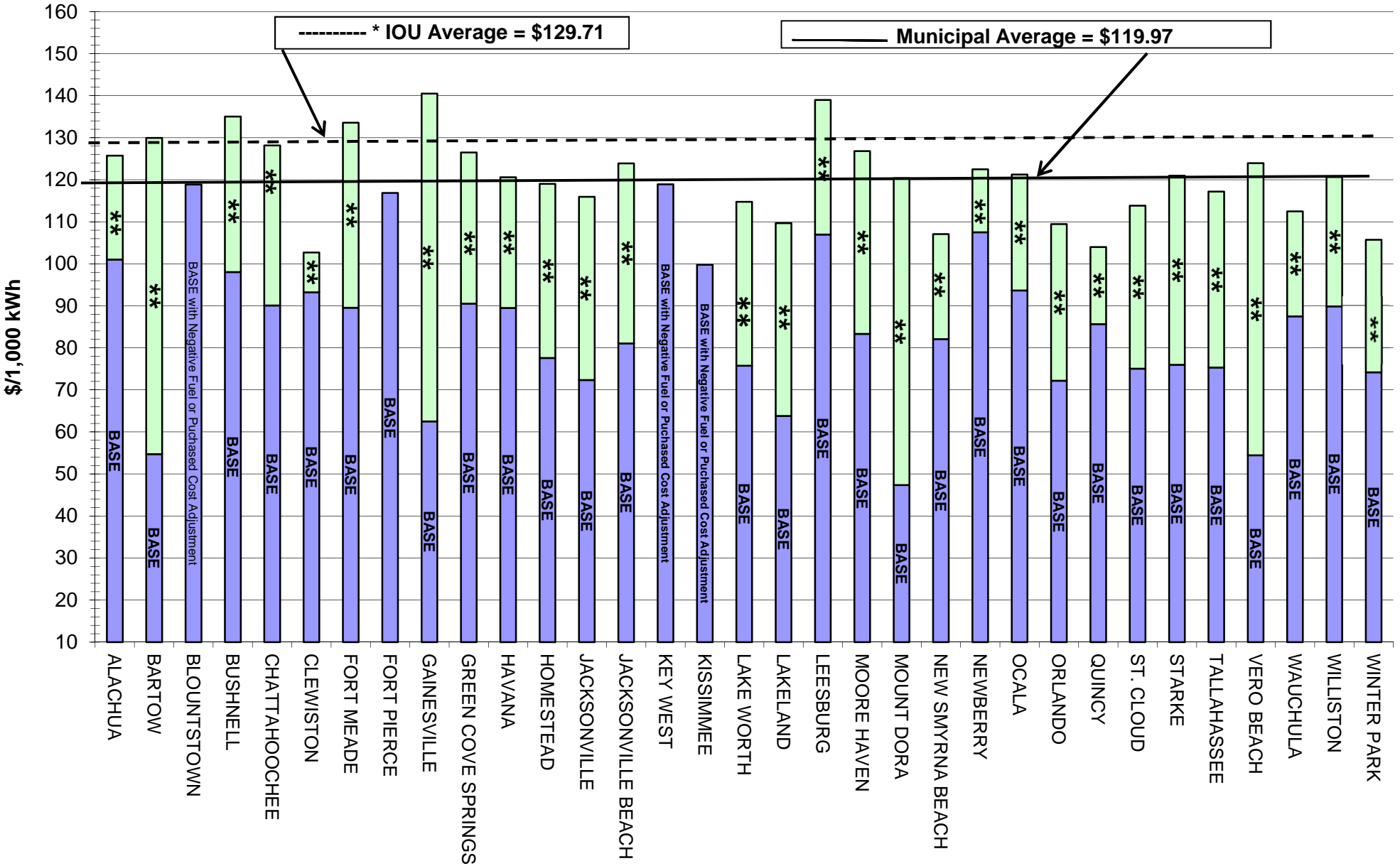


Residential Bill Comparison, March 2015

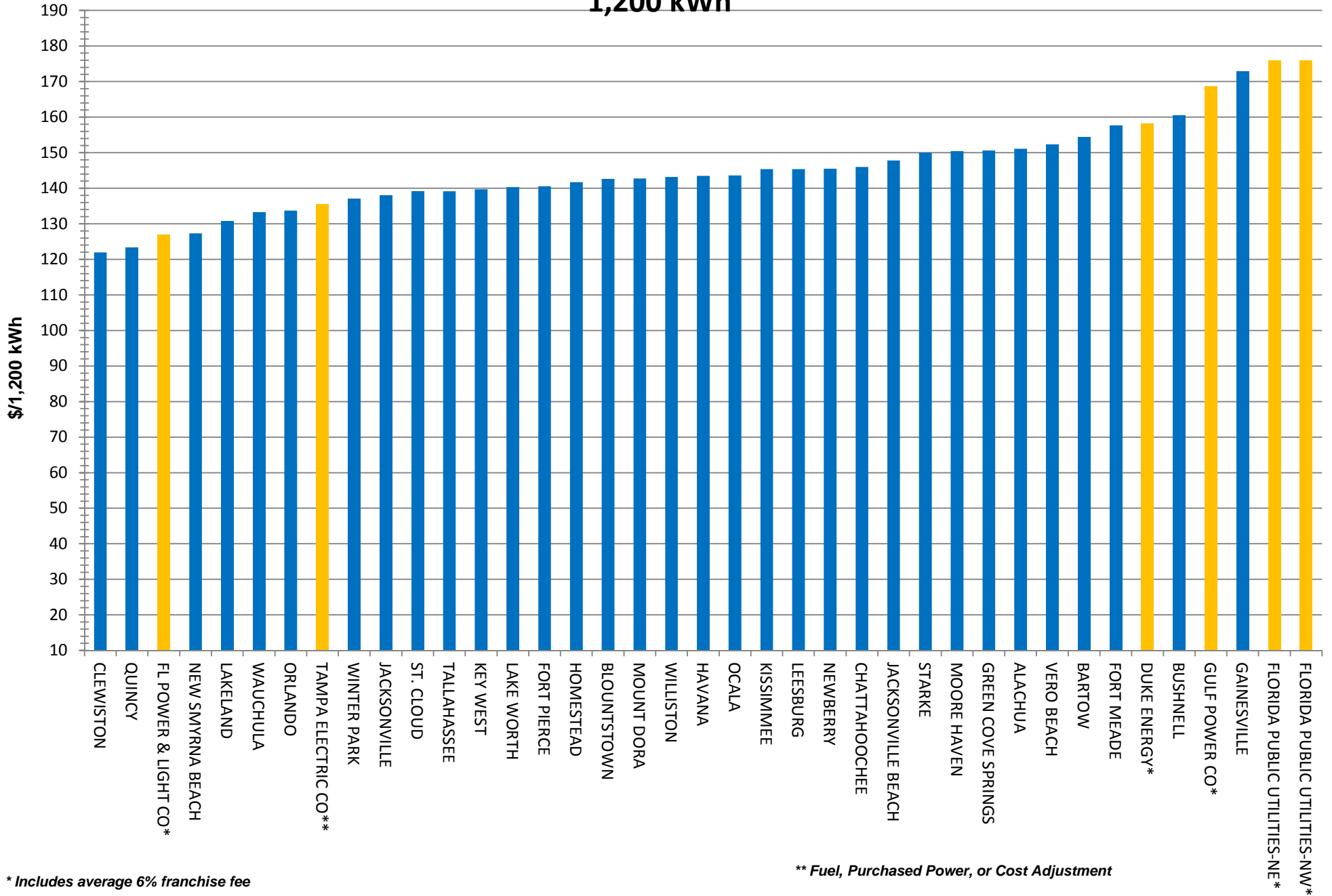
