**GENERAL DESCRIPTION:** Highly skilled technical work in the operation and maintenance of high voltage substations and SCADA Computer System. Position reports directly to Electric T&D Superintendent.

**ESSENTIAL MINIMUM EDUCATION AND EXPERIENCE:** Graduation from an accredited high school with courses in math and science. Satisfactory completion of an approved training course in electronics and/or electricity from one of the following: military, trade school or college, with four years experience in substation maintenance, relay testing and SCADA Computer Systems. When considering new job applicants, a comparable amount of training and experience may be substituted for the minimum qualifications. An appropriate valid State of Florida Operator's License with the ability to obtain a **Class "A" CDL within three (3) months of date of hire**. CDL License needed sparingly for emergencies.

**ESSENTIAL PHYSICAL SKILLS:** Moderate carrying and lifting; walking; standing; kneeling, climbing; bending; balancing; smelling, stooping, driving.
